- Always have pets on a leash.
- Read and obey all posted information and warnings.
- Comply promptly with all verbal directions of staff personnel, officers and instructors unless I believe that by doing so I will endanger myself, other people or pets, in which case I will immediately express my opinion to the person involved.
- Refrain from acting in any manner that may cause or contribute to my injury or the injury of other people or pets.
- Never leave pets unattended or alone.

- o Be constantly aware of, anticipate and be able to avoid nearby pets, people, obstacles and natural or man-made hazards.

I understand that this is only a partial list, and I must be safety conscious and exercise sound judgment at all times. Anyone found to be endangering themselves, other people, or pets faces immediate revocation of pet privileges.
